<ol style="list-style-type: none"> 1. Very good uptake of extra-curricular activities which are well recorded analysed. All children across the school have access to the extra-curricular activities. 2. Good use of TAs at lunchtime to encourage children to participate in active lunchtimes. 3. Good pupil engagement in healthy lifestyles and well-being sessions. 	<ul style="list-style-type: none"> • Continued need for CPD for staff to ensure all remain confident with a range of sports and physical activities. • By the end of Year 6, the majority of our children are not confident swimmers with very few being able to swim 25m. Appreciating this need, we plan to introduce swimming into two year groups to meet the requirements of the national curriculum. We will also start swimming lessons in our federated infant school in year 2 to develop water confidence as soon as there is pool availability.

Source suitable coaches and trainers to run extra-curricular provision. • Provide opportunities for staff development through observation and specific training 1 x coach to work closely with each year group each week. • 4 x lunchtime activities led by sports coach accessible to all children 	<p>Cost of SSP = £5,157.80</p> <p>Total cost of coach providing additional training 4 x weekly with each year group and 4 x lunchtime activities for children = £18,420 (Subsidise with Sum from Sport Premium = £10,800)</p>	<ul style="list-style-type: none"> • The SSP provided online learning during the pandemic that was available to all pupils at the school through their website (advertised through Class Dojo and the schools Canva magazine). In the summer term children were able to take part in a virtual skipping challenge in school. Y6 girls also took part in a football festival. The nature of the virtual learning enabled all children in the school to take part in at least one SSP activity. • In consultation with Premier Sport we had planned on providing less accessible sports as part of their after school provision, e.g. fencing and archery. This was disrupted by Covid-19. • All teachers developed their teaching of PE through working with a specialist sports coach from Premier Sport (at least once a week for half a term). • Lunchtime activities led by a Premier Sports coach have continued throughout the year. These continued in lockdown with the key worker/vulnerable children that were in school.
